All sales are final. There will be no refunds given on any purchase. The customer has the ability to have the build process indefinitely stopped, but agrees to pay for all parts and fees that have incurred up until the point the customer stopped the build.

Once a vehicle is ready for pickup, customers have 30 days to pay their balance and pick up their property or it becomes property of Sinister Sand Sports.

offer and recommend California Air Resource Board (C.A.R.B.) EPAcertified powerplants, other powerplants are available to customers. It is understood that any non compliant engine package is not to be driven on public roads or property. It is the sole responsibility of the owner/operator of the vehicle to make sure they are compliant with any applicable laws that are required for the owner/operator's intended use in their area.
